## 1 亞瑞仕和獲證組織的權利和義務 The right and obligation of ARES and certified client

### 1.1 獲證組織的權利和義務 The right and obligation of certified client

#### a) 獲證組織的權利 The right of certified client

——獲證組織可按本文件有關規定，使用亞瑞仕頒發的驗證證書和標誌，宣傳其驗證資格；The certified client has the right to use the certificate and logo that awarded by ARES to propaganda their certified qualification.

——獲證組織可要求獲取最新版本的 ARES-WI-20《驗證證書及驗證標誌使用規則》文件；The certified client has the right to achieve the newest version document ARES-WI-20《The use rules for certificate and logo》

——對亞瑞仕發出的誤用證書和標誌的更改通知，可發表意見，以保護自身利益。The certified client has the right to give suggestion to ARES for the notice of misusing certificate and logo, to protect their own interest via

#### b) 獲證組織的義務 The obligation of the certified client

——始終遵守驗證規範和本文件的有關規定。Always abide by certification provision and relevant rules of this document.

——正確的使用驗證證書和驗證標誌。Proper use the certificate and logo.

——獲證組織應及時向亞瑞仕報告其對管理系統擬實施的更改或其他可能影響其符合性的更改，如管理手冊的更改、組織機構的調整、中心地址的變更等，以便驗證機構能掌握最新的變更資訊，未能提供這些變更資訊的將被視為對驗證證書的誤用，並按本規則採取相應措施。For ARES can get the newest change information ,the certified client should report to ARES in time if they want to conduct any change in management system or other changes may impact conformity, such as any change for manual, for o-chart, for main address. If the certified client didn't submit those change information, will be regarded as misusing the certificate. ARES will take relevant action according to this document.

## 1.2 亞瑞仕的權利和義務 The right and obligation of ARES

### a) 亞瑞仕的權利 The right of ARES

——對驗證證書和驗證標誌擁有所有權；Has the own right for certificate and logo

——制定管理系統驗證證書和驗證標誌的使用規則；Has the right to set up the use rules for the certificate and logo

——通過定期的追查稽核和必要的不定期抽查（如：獲證組織出現重大的顧客抱怨、重大的產品品質事故、安全事故和/或環境污染事故等），持續驗證組織對法律法規的符合性；Has the right to monitor the conformity of certified client abiding by laws and rules via regular surveillance and necessary random inspection.(eg. The certified client occur serious customer complain, serious product quality accident, security accident or environmental pollute accident)

——對誤用或錯用驗證證書和驗證標誌有權採取必要的措施予以矯正，直至終止驗證和採取其他法律手段。Has the right to take action for misuse certificate and logo to correct, till terminate the certification and take other law tools.

### b) 亞瑞仕的義務 The obligation of ARES

——對所頒發的驗證證書在驗證範圍內的管理系統對特定標準或其他引用文件的符合性負責；ARES should be responsible for the conformity of the specific standard or other quoted standard that within the certification scope.

## 2 驗證證書和標誌管理 management of certificate and logo

### 2.1 驗證證書的資訊及管理要求 Information and management requirement for certificate.

2.1.1 亞瑞仕的驗證證書是由亞瑞仕國際驗證股份有限公司頒發給受稽核方，證明其管理系統符合相應驗證標準要求的證明文件，分中文、英文兩種版本。 The certificate of ARES is granted to certified organization, to prove the management system of certified organization meet the requirement of standard. The certificate has two version, Chinese version and English version.

### 2.1.2 管理系統驗證證書的內容 The content of the management system certificate

  - j) 驗證公司總經理的簽字；
  - k) 驗證標誌、認證標誌。

  - c) The granting, expanding or updating or renew certificate date

- d)The validity period for the certification or the recertification date
- e)The registration number of the certification.
- f)The number and version of management system standard/other normative reference
- g)The scope covered by the management system certification.
- h)The name, address, telephone number and website of the certification body
- i)All other information required by the certification standard or other normative reference
- j)The signature of the GM of certified body
- k) The logo of certification body and the symbols of accreditation body.

### 2.1.3 驗證證書的簽發 Issue certificate

- a)驗證決定人員作出驗證決定後，經總經理簽發驗證證書，給予驗證註冊。after the decision maker make certification decision, GM shall issue certificate and register the certification.
- b)通常對同一個組織實施同一個管理系統驗證，只賦予一個註冊號，發放一張證書，若獲證組織有兩個名稱，可在證書上註明，但不能賦予兩個註冊號，頒發兩張證書。General speaking, our company will grant one registration number, just grant one certificate if the certified organization just implement one single management system. If the certified organization has multiple name, will remark on the certificate, rather than grant two registration number and grant two certificate.

- e)驗證證書生效日不得在驗證決定日期之前。The effect date of the certificate shouldn't be prior to the certification decision date

### 2.1.4 驗證證書的更換 Change for the certificate

- a ) the owner of the certificate changed

上述變更情況的更換證書，宜在正常的追查稽核前提出，在正常的追查稽核中同步確認變更。驗證證書有效期滿，經重新驗證稽核，確認保持註冊資格，書面通知給予換發證書。換發的證書應重新賦予註冊號。Above status need change the certificate, the certified organization should apply before the surveillance audit, will confirm the change with the surveillance audit. When the certificate is out of date, after recertification, confirm the qualification, written notice the new certificate. The new certificate should be granted a new registration number.

#### 2.1.5 補發驗證證書 Certificate supplement

當獲證組織驗證證書遺失或損毀時，應向公司提出書面申請，說明理由，經公司總經理核定後補發驗證證書。When the certified organization lost or damaged their certificate. They should submit the written application to the company and explain the reasons; we can supplement a certificate after got approval from our general manager.

#### 2.1.6 驗證暫時終止、終止的通報 Notice certificate terminate use or temporary terminate use

驗證證書的暫時終止及終止、對到期未申請重新驗證以及其他變更資訊由管理部在公司網站上公佈。Our management department shall make written notice on our website if the certificate of the certified organization need to be terminate using or temporary terminate using.

#### 2.1.7 獲證組織使用驗證證書的要求 Requirement for the use of the certificate

- a) 管理系統驗證證書只能由獲證組織在證書有效期內和獲准驗證範圍內使用，不准以任何方式轉讓、出售或借用、冒用。Management system certificate should be used within validity date and approved scope, can't transfer, sell, borrow or falsely use in any way.

- b) 獲得公司驗證的組織可以在其公開出版物、宣傳品、網頁等載體上展示驗證證書，但應保證其清晰可辨。Certified organization could show their certificate in its publications, advertising materials, website, but ensure that is clear.
- c) 驗證證書有效期為三年，在有效期內，經公司追查稽核已確認保持註冊資格後，獲證組織方可繼續使用管理系統驗證證書。The validity period of the certificate is three year. After our company complete the surveillance audit within the validity period, confirm the qualification, certified organization shall continuously use the certificate.
- d) 因不符合驗證要求，被暫時終止及終止驗證資格時，應停止使用驗證證書和標誌。終止驗證資格時將驗證證書交回公司。Due to can't meet the certification requirement, the certificate shall be terminate use or temporarily terminate use, the organization should terminate using the certificate and logo timely, and return the certificate to our company.

## 2.2 驗證標誌、認證標誌的資訊和管理 management for the ARES logo, accreditation Symbols

### 2.2.1 亞瑞仕驗證標誌 ARES certificate logo



2.2.1.1 驗證標誌是為了表明獲證組織的某一管理系統，根據亞瑞仕驗證程序實施驗證後，符合適用的管理系統標準和相關技術規範要求的特有標誌。驗證標誌適用於驗證證書和獲證組織在驗證的範圍內宣傳和使用。The requirement and scope for our company logo using. The certification logo is to indicate that the management system of certified organization meet the management system standard requirement and relevant technical requirement.

2.2.2.1 認證標誌為亞瑞仕通過認證組織之認證所獲取具有認證號碼之標誌。亞瑞仕使用認證標誌之證書、宣傳品、廣告等，遵循TAF之「驗證機構認證證書及認證標誌使用規定」、UKAS之「ACCREDITATION LOGO&SYMBOLS」及IAS「Transition to New Corporate Logos and Accreditation Symbols」等相關規定，並予管制及記錄，認證組織(如TAF、UKAS、IAS等)得以隨時查核。The accreditation symbols are a symbol of the certification number obtained by accreditation organization. (Hereinafter referred to as "ACCREDITATION LOGO & SYMBOLS" and the relevant regulations of the UKAS), IAS "Transition to New Corporate Logos and Accreditation Symbols "and to control and record, certify the organization (such as the use of the certification certificate and certification mark, TAF, UKAS, IAS) at any time check.

2.2.2.2 下列為ARES使用UKAS SYMBOLS之原則

Only UKAS may use the relevant national accreditation logo on stationery, quotations for work, reports and certificates, websites and brochures, and other items relevant to UKAS' accreditation activities, subject to the conditions set out in 「ACCREDITATION LOGO&SYMBOLS」.

2) 只有 ARES 可以在文具，工作報價，報告和證書，網站和小冊子以及與認證組織的認證活動相關的其他項目中使用 accreditation symbols(如 2.2.2)

Only ARES accredited by UKAS may use the relevant national accreditation symbols on stationery, quotations for work, reports and certificates, websites and brochures, and other items relevant to the accredited organisation's accredited activity, subject to the conditions set out in 「ACCREDITATION LOGO&SYMBOLS」

3) 證書持有人可以根據本程序關於文具和宣傳材料或與其證書相關的其他項目的要求，使用 UKAS 標誌應始終與 ARES LOGO 一起使用。

Holders of certificates issued by UKAS accredited certification bodies may use the appropriate national accreditation symbol in accordance with the requirements of this publication on stationery and publicity material or other items relevant to their certificate. The national accreditation symbol(s) shall always be used in conjunction with the logo/mark of the certification body or certification scheme.

Any use of the national accreditation logo or symbols that might contravene the conditions laid down in 「ACCREDITATION LOGO&SYMBOLS」 shall be referred to UKAS.

7) 標誌的使用不得暗示 UKAS 對在認可和/或認證範圍內開展的活動承擔責任。

The national accreditation symbols shall not be used in such a way as to imply that UKAS accepts responsibility for activities carried out under the scope of accreditation and/or certification.

8) ARES 有責任盡量降低客戶/讀者被誤導其 UKAS 認證程度和限制的風險，無論是與工作報價，正在進行的工作，報告的結果，使用分包商或用於廣告活動或服務的任何宣傳材料（例如網站和小冊子）。

It is the responsibility of ARES to minimise the risk of a client/reader being misled as to the extent and limitations of its UKAS accreditation, whether it be in relation to quotations for work, work being undertaken, results being reported, the use of sub-contractors or in any publicity material (e.g. websites and brochures) used for advertising activities or services.

activities and non-accredited and/or subcontracted activities shall readily distinguish the activities that are covered by the organisation’s accreditation and those that are not.

10) 所有含有標誌的工作報價應清楚地表明那些未經 UKAS 認證的活動。

All quotations for work that contain a national accreditation symbol shall clearly indicate those activities that are not UKAS accredited.

11) ARES 的客戶只能使用 accreditation symbols(如 2.2.2)。標誌必須與證書上一致。

The appropriate national accreditation symbol may only be used by the client of a certification body in connection with the certification body’s award of UKAS accredited certification. The national accreditation symbol must be relevant to the certificate.

12) ARES 有權在涉及被認證服務的宣傳材料中加入適當的國家認可標誌，前提是滿足「ACCREDITATION LOGO&SYMBOLS」中包含的與其複製相關的條件。

ARES are entitled to incorporate the appropriate national accreditation symbol(s) in publicity material that refers to accredited services, provided that the conditions relating to their reproduction contained in 「ACCREDITATION LOGO&SYMBOLS」 are met.

This restriction shall also apply to primary (e.g. blister packs) packaging and promotional products.

ARES may display their national accreditation symbols on internal walls and doors, and on exhibition stands.

2.2.3 獲證組織驗證標誌、認證標誌使用規則 The requirement for certified organization to use our ARES logo, accreditation Symbols.

a) 亞瑞仕獲得的認證標誌、互認標誌必須與亞瑞仕驗證標誌合併使用，不可單獨使用，標誌大小以相同尺寸為原則；Accreditation logo and mutual recognition logo must be used combine with ARES certification logo, they can't be separately used, and is the same size.

b) 驗證標誌和認證標誌必須印在清晰的背景下，包括所有的邊界線使用鮮明的色彩印刷；the verification logo and certification logo must be printed with clear background, including all border lines should be printed with strong colours.

c) 互認標誌、亞瑞仕獲得的認證標誌和亞瑞仕驗證標誌只允許使用與亞瑞仕所提供色調一致的彩色認證、驗證標誌或黑白互認、認證、驗證標誌（根據驗證組織需要亞瑞仕提供其標誌的電子版）。使用該標誌時，可根據亞瑞仕提供的圖樣按比例放大或縮小，任何尺寸的標誌都必須清晰可辨，不得變形或裁切使用，標誌下方之認證註冊號必須清晰可識別；the mutual recognition logo, the ARES obtained certification logo and ARES verification logo should be only used as same colour as ARES colour certification/verification logo or black and white colour mutual recognition logo, certification logo, verification logo.(it should be decided by customer request). When use those logoes, can magnify or shrink based on the same scale as ARES supplied, all size logoes should be clear to recognize, any deform using is not allowed. Shall not be deformed or cut to use, the logo below the registration number must be clearly identified




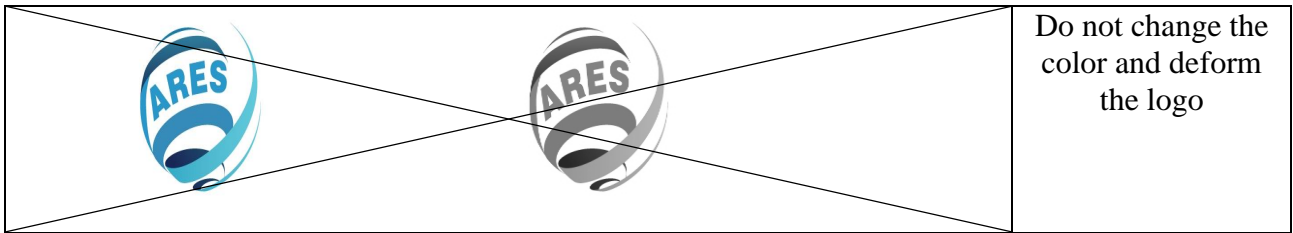
