1 亞瑞仕和獲證組織的權利和義務 **The right and obligation of ARES and certified client**

1.1 獲證組織的權利和義務 **The right and obligation of certified client**

a) 獲證組織的權利 **The right of certified client**

——獲證組織可按本文件有關規定，使用亞瑞仕頒發的聲明書和標誌，宣傳其通過查證；
The certified client has the right to use the statement and logo that awarded by ARES to propaganda their certified qualification.

——獲證組織可要求獲取最新版本的 ARES-VWI-20 《聲明書及標誌使用規則》文件；
The certified client has the right to achieve the newest version document ARES-VWI-20 《Statement and mark usage rules》

b) 獲證組織的義務 **The obligation of the certified client**

——始終遵守查證規範和本文件的有關規定。Always abide by verification provision and relevant rules of this document.

——正確的使用聲明書和標誌。Proper use the statement and logo.

——及時繳納查證有關費用。The certified client should pay verification relevant fee timely.

1.2 亞瑞仕的權利和義務 **The right and obligation of ARES**

a) 亞瑞仕的權利 **The right of ARES**

——對聲明書和標誌擁有所有權；Has the own right for statement and logo

——制定聲明書和標誌的使用規則；Has the right to set up the use rules for the statement and logo

——對誤用或錯用聲明書和標誌有權採取必要的措施予以矯正，採取其他法律手段。Has the right to take action for misuse statement and logo to correct, and take other law tools.

b) 亞瑞仕的義務 **The obligation of ARES**

——對所頒發的聲明書在查證範圍內的系統對特定標準或其他引用文件的符合性負責；
ARES should be responsible for the conformity of the specific standard or other quoted standard that within the verification scope.

——經要求時，提供確證/查證聲明的簽發狀態；when request, the issue status of the validation/verification statement.

2 聲明書和標誌管理 **management of certificate and logo**

2.1 聲明書的資訊及管理要求 **Information and management requirement for statement.**

2.1.1 亞瑞仕的聲明書是由亞瑞仕國際驗證股份有限公司頒發給受查證方，證明其系統符合相應查證標準要求的證明文件，分中文、英文兩種版本。The statement of ARES is granted to verified organization, to prove the management system of certified organization meet the requirement of standard. The statement has two version, Chinese version and English version.

2.1.2 聲明書的內容 The content of the statement

- a) 說明客戶名稱；
 - b) 鑑別聲明是屬於確證聲明或是查證聲明；
 - c) 關於主張，包括主所涵蓋的日期與期間；
 - d) 包含與所述聲明有關的確證/查證機構的類型(亦即第一者、第二者或第三者)；
 - e) 包含確證/查證機構的名稱與地址(如果含有標誌，例如：認證標誌，則這些標誌不會誤導或模糊不清)；
 - f) 描述確證/查證的目標與範圍；
 - g) 描述佐證該主張的資料與資訊是否屬於假設、預測及/或歷史性質；
 - h) 包含引用的確證/查證方案與相關特定的要求；
 - i) 包含關於對該主張的決定，包括履行任何方案相關的要求(例如：實質性或保證等級)；
 - j) 指明聲明日期與唯一的識別號；
 - k) 包含任何在簽發確證/查證聲明前尚未解決的發現，如果方案有要求。
- a) state the client's name
 - b) identify whether it is a validation statement or a verification statement;
 - c) refer to the claim, including date or period which the claim covers;
 - d) include the type of the validation/ verification body in relation to the statement in question (i.e. first party, second party or third party);
 - e) include the name and address of the validation/ verification body (if symbols, e.g. accreditation symbol, are included, they shall not be misleading or ambiguous);
 - f) describe the objects and scope of the validation/ verification;
 - g) describe whether the data and information supporting the claim were hypothetical, projected and/ or historical in nature;
 - h) include a reference to the validation/ verification programme and associated specified requirements;
 - i) include the decision made about the claim, including the fulfilment of any programme related

requirement (e.g. materiality or level of assurance);

j) indicate the date and the unique identification of the statement;

k) include any findings, that have not been addressed prior to the issue of the validation/ verification statement,

2.1.3 聲明書的簽發 Issue statement

a) 查證審查人員作出決定後，經總經理簽發聲明書。after the verification reviewer make decision, GM shall issue statement.

b) 聲明書生效日不得在審查決定日期之前。The effect date of the statement shouldn't be prior to the statement decision date

2.1.4 獲證組織使用聲明書的要求 Requirement for the use of the certificate

a) 聲明書只能由獲證組織使用，不准以任何方式轉讓、出售或借用、冒用。Statement should be used within verified company, can't transfer, sell, borrow or falsely use in any way.

b) 獲證組織可以在其網頁等載體上展示聲明書，但應保證其清晰可辨。Verified organization could show their statement in its website, but ensure that is clear.

2.2 查證標誌、認證標誌的資訊和管理 management for the ARES logo, accreditation Symbols

2.2.1 亞瑞仕查證標誌 ARES logo



2.2.1.1 查證標誌是為了表明獲證組織的某一系統，根據亞瑞仕查證程序實施查證後，符合適用的系統標準和相關技術規範要求的特有標誌。查證標誌適用於聲明書和獲證組織在查證的範圍內宣傳和使用。The requirement and scope for our company logo using. The verification logo is to indicate that the system of certified organization meet the system standard requirement and relevant technical requirement.

2.2.2.1 認證標誌為亞瑞仕通過認證組織之認證所獲取具有認證號碼之標誌。亞瑞仕使用認證標誌之證書、宣傳品、廣告等，遵循TAF之「驗證機構認證證書及認證標誌使用規定」、UKAS之「ACCREDITATION LOGO&SYMBOLS」及IAS「Transition to New Corporate Logos and Accreditation Symbols」等相關規定，並予管制及記錄，認證組織(如TAF、IAS等)得以隨時查核。The accreditation symbols are a symbol of the certification number obtained by accreditation organization. (Hereinafter referred to as "ACCREDITATION LOGO & SYMBOLS" and the relevant regulations of the UKAS), IAS "Transition to New Corporate Logos and Accreditation Symbols "and to control and record, certify the organization (such as the use of the certification certificate and certification mark, TAF, UKAS, IAS) at any time check.

2.2.3 獲證組織查證標誌、認證標誌使用規則 The requirement for certified organization to use our ARES logo, accreditation Symbols.

- a) 亞瑞仕獲得的認證標誌必須與亞瑞仕查證標誌合併使用，不可單獨使用，標誌大小以相同尺寸為原則；Accreditation logo must be used combine with ARES certification logo, they can't be separately used, and is the same size.
- b) 查證標誌和認證標誌必須印在清晰的背景下，包括所有的邊界線使用鮮明的色彩印刷；the verification logo and certification logo must be printed with clear background, including all border lines should be printed with strong colours.
- c) 亞瑞仕獲得的認證標誌和亞瑞仕查證標誌只允許使用與亞瑞仕所提供色調一致的彩色認證、查證標誌或黑白認證、查證標誌（根據查證組織需要亞瑞仕提供其標誌的電子版）。使用該標誌時，可根據亞瑞仕提供的圖樣按比例放大或縮小，任何尺寸的標誌都必須清晰可辨，不得變形或裁切使用，標誌下方之認證註冊號必須清晰可識別；the ARES obtained certification logo and ARES verification logo should be only used as same colour as ARES colour certification/verification logo or black and white colour mutual recognition logo,

Shall not be deformed or cut to use, the logo below the registration number must be clearly identified

e) 標記之使用 Use of Marks

標記使用管理規則須包括標記的使用，旨在確保負責者不使用標記用以暗示未經確證或查證之聲明已通過確證或查證，例如，使用機構標記得包括將其附加於負責者環境資訊報告中描述經確證或查證環境資訊的旁邊。Mark usage management rules must include the use of the mark to ensure that the responsible person does not use the mark to imply that an unsubstantiated or verified claim has been corroborated or verified. For example, the use of the mark by the agency may include attaching it to the responsible person's environmental information report. next to the corroborated or verified environmental information described in. 環境資訊聲明中包含未經確證或查證資訊，禁止使用機構標記，下列說明可接受與不可接受之標記使用範例。The Environmental Information Statement contains unverified or verified information, and the use of agency marks is prohibited.
