personnel shall participate in any consulting activities related to its greenhouse gas validation/verification services.

4) 開展溫室氣體<mark>查驗</mark>工作不以營利為目的,對內不做<mark>查驗</mark>數量或經濟承包。對外不以不 正當手段進行市場競爭,查驗收費按照相關規定執行;

Greenhouse gas validation/verification activities are not conducted for profit. Internally, there are no targets or economic incentives based on the number of validations/verifications. Externally, the company does not engage in unfair market competition, and all validation/verification fees are charged in accordance with relevant regulations.
