### 1 亞瑞仕和獲查證組織的權利和義務 The right and obligation of ARES and verified client

- 1.1 獲查證組織的權利和義務 The right and obligation of verified client
  - a) 獲查證組織的權利 The right of verified client
  - ——獲查證組織可按本文件有關規定,使用亞瑞仕頒發的聲明書和標誌,宣傳其通過查
  - 證; The verified client has the right to use the statement and logo that awarded by ARES to propaganda their verified qualification.
  - ——獲查證組織可要求獲取最新版本的 ARES-VWI-20《聲明書及標誌使用規則》文件; The verified client has the right to achieve the newest version document ARES-VWI-20《Statement and mark usage rules》
  - b) 獲查證組織的義務 The obligation of the verified client
  - ——始終遵守查證規範和本文件的有關規定。Always abide by verification provision and relevant rules of this document.
  - ——正確的使用聲明書和標誌。Proper use the statement and logo.
  - ——及時繳納查證有關費用。The verified client should pay verification relevant fee timely.
- 1.2 亞瑞仕的權利和義務 The right and obligation of ARES
  - a) 亞瑞仕的權利 The right of ARES
  - ——對意見書和標誌擁有所有權;Has the own right for opinion and logo

- 2.1 意見書的資訊及管理要求 Information and management requirement for opinion.
- 2.1.1亞瑞仕的意見書是由亞瑞仕國際驗證股份有限公司頒發給受查證方,證明其系統符合相應查證標準要求的證明文件,分中文、英文兩種版本。 The opinion of ARES is granted to verified organization, to prove the system of verified organization meet the requirement of standard. The opinion has two version, Chinese version and English version.
- 2.1.2 意見書的內容 The content of the opinion

### 2.2.2.1 TAF 認證標誌. TAF Accreditation Symbols

### 2.2.2.1.1 使用範圍 The scope of use

### 2.2.2.1.2 使用期間 The period of use

### 2.2.2.1.3 使用原則 The principle of use

#### 2.2.2.1.4 使用限制 The limitation of use

- 2.2.3 獲查證組織查證標誌、認證標誌使用規則 The requirement for verified organization to use our ARES logo, accreditation Symbols.
  - a) 通過本公司查證的客戶,不得使用TAF認證標誌及標章。Customers who have passed the verification by ARES shall not use TAF certification symbol or TAF mark.

- 3.2 客戶使用此亞瑞仕特定文檔的規則 Rule for client when use of ARES specific text or documents.
  - a) 收到亞瑞仕交付特定文檔的的客戶,不准以任何方式轉讓、出售或借用、冒用。Client that received specific text or documents, shall not transfer, sell, borrow or falsely use in any way.
  - b) 客戶應同意此特定文檔需完整被保存與使用,因此不得任意擷取其中部分內容。Client shall agree that ARES specific text or documents be used and saved in whole contents, any partial section shall not be used arbitrarily.
  - c) 客戶應同意亞瑞仕於必要時撤回此交付之特定文檔,不得拒絕且不得另行留存複本. Client shall agree that ARES could withdraw the delivered specific text or documents when necessary. Client shall not refuse ARES, and client shall not save any duplication of ARES specific text or documents.
